- 37. <u>Mueller Supplemental Covenant</u> recorded as Document No. of the Official Public Records of Travis County, Texas, pertaining to Lots 8-15, Block 83, of Mueller Section 10A Subdivision, a subdivision in Travis County, Texas, according to the map or plat thereof, recorded under Document No. 201600198 of the Official Public Records of Travis County, Texas.

- B. Pursuant to the amendment provisions contained in *Article 3* of the Row House Supplemental Covenants, Master Declarant may unilaterally amend the Row House Supplemental Covenants for any purpose during the Development and Sale Period. The Development and Sale Period is currently in effect.
- C. Pursuant to Section 1.5 of the Mueller Master Community Covenant, recorded as Document No. 2004238007 in the Official Public Records of Travis County, Texas, as amended (the "Master Covenant"), the City of Austin must consent to any supplemental covenant which contains covenants, restrictions, conditions, limitations and/or easements affecting all or any portion of the Community (as defined in the Master Covenant). The City of Austin does hereby consent to this Amendment by its execution of this instrument.
- D. Master Declarant desires to amend the Row House Supplemental Covenants as set forth herein.

NOW, THEREFORE, the Master Declarant hereby amends and modifies the Row House Supplemental Covenants as follows:

- 1. <u>Insurance</u>. The following is hereby added (or if subsection (f) already exists, the following replaces subsection (f)) in the Section entitled "Notice of Service Area" located in *Article 3* of the Row House Supplemental Covenants [located either in *Section 3.02* or *3.03* of each Row House Supplemental Covenant]:
 - Insurance Coverage Provided by the Master Association. Notwithstanding anything contained herein to the contrary, within the service area(s) designated by this Supplemental Covenant, the Master Association, as a Service Area Expense, will obtain and maintain property insurance on each Owner's Dwelling Unit (the "Dwelling Property Insurance"). The Dwelling Property Insurance is intended to provide insurance coverage to restore the Dwelling Units covered by the Dwelling Property Insurance to the Dwelling Unit's original as-built condition, being the condition of the Dwelling Unit as originally constructed excluding improvements and betterments installed by the Owner and excluding personal property of an Owner or their guest or invitees. Each Owner is advised that the Dwelling Property Insurance obtained by the Master Association may be less than the actual value of the Dwelling Unit, will not cover improvements and betterments installed by the Owner, and will not cover personal property of an Owner or their guest or invitees. Notwithstanding the foregoing, the Master Association may elect to obtain a property insurance policy that covers improvements and betterments installed by the Owner.

Each Owner is advised to contact the Owner's insurance agent to determine and obtain additional insurance coverage for improvements and betterments installed by the Owner and personal property of the Owner or their guest or invitees. The Master Association will make available, or provide to each Owner upon written request, a copy of the Dwelling Property Insurance obtained and maintained by the Master Association.

EACH OWNER SHALL RELEASE AND HOLD HARMLESS THE MASTER ASSOCIATION AND MASTER DECLARANT, AND THEIR RESPECTIVE DIRECTORS, OFFICERS, COMMITTEES, AGENTS, AND EMPLOYEES, FROM AND AGAINST ANY LIABILITY AND/OR ANY AMOUNT, COVERAGES, THE **RELATED** TO **DAMAGES EXCLUSIONS ASSOCIATED** ENDORSEMENTS, AND/OR ATTRIBUTABLE TO THE DWELLING PROPERTY INSURANCE, IT BEING UNDERSTOOD AND AGREED THAT EACH OWNER SHALL HAVE THE SOLE AND EXCLUSIVE RESPONSIBILITY TO OBTAIN MAINTAIN PROPERTY INSURANCE COVERING DWELLING OR PERSONAL PROPERTY NOT EXPRESSLY INSURED BY THE DWELLING PROPERTY INSURANCE.

The Master Association shall have the right and authority to allocate the premiums attributable to the Dwelling Property Insurance to each Dwelling Unit, which allocation may be a fixed amount irrespective of the size or location of the Dwelling Unit, or in accordance with an alternative methodology determined from time to time by the Master Board provided such methodology is consistently applied. To the extent the Master Association obtains coverage for additional Units not subject to this Amendment (the "Other Units"), but otherwise subject to the terms and provisions of the Master Covenant, the Master Association shall have the right and authority to allocate the premiums attributable to the Dwelling Property Insurance to each Dwelling Unit and Other Units, which allocation may be a fixed amount irrespective of the size or location of the Dwelling Unit and Other Units, or in accordance with an alternative methodology determined from time to time by the Board provided such methodology is consistently applied. The amounts allocated by the Master Association for premiums attributable to the Dwelling Property Insurance is secured by the lien reserved in the Master Covenant for assessments and may be collected by any means provided in the Master Covenant for the collection of assessments, including, but not limited to, foreclosure of such liens.

2. <u>Maintenance Responsibility Chart</u>. To the extent that each Row House Supplemental Covenant includes a Maintenance Responsibility Chart attached as <u>Exhibit "A-1"</u> or <u>Attachment 1-B</u>, the following is added (or if "Property insurance" already exists in such Maintenance Responsibility Chart, the following replaces "Property insurance") in the Maintenance Responsibility Chart attached as <u>Exhibit "A-1"</u> or <u>Attachment 1-B</u> of the Row House Supplemental Covenants:

- 3. <u>Flex Home Supplemental Covenant</u>. This Section shall not apply to all of the Row House Supplemental Covenants, but shall only apply to the Flex Home Supplemental Covenant. *Section 5* and *Section 6* of <u>Exhibit "A"</u> attached to the Flex Home Supplemental Covenant are hereby deleted in their entirety.
- 4. <u>Miscellaneous</u>. Any capitalized terms used and not otherwise defined herein shall have the meanings set forth in the Master Covenant. Unless expressly amended by this Amendment, all other terms and provisions of the Row House Supplemental Covenants remain in full force and effect as written, and are hereby ratified and confirmed.
