RECITALS:

- A. Master Declarant previously executed and recorded that certain Mueller Master Community Covenant, recorded as Document No. 2004238007 in the Official Public Records of Travis County, Texas, as corrected by that certain Scrivener's Affidavit, recorded as Document No. 2005039311 in the Official Public Records of Travis County, Texas, as amended by that certain First Amendment to Mueller Master Community Covenant, recorded as Document No. 2006050356 in the Official Public Records of Travis County, Texas, as further amended by that certain Second Amendment to Mueller Master Community Covenant, recorded as Document No. 2006193523 in the Official Public Records of Travis County, Texas, as further amended by that certain Third Amendment to Mueller Master Community Covenant, recorded as Document No. 2009190773 in the Official Public Records of Travis County, Texas, and as further amended by that certain Fourth Amendment to Mueller Master Community Covenant, recorded as Document No. 2010193075 in the Official Public Records of Travis County, Texas (collectively, the "Master Covenant").
- B. Pursuant to Section 20.2 of the Master Covenant, during the Development and Sale Period, the Master Declarant may unilaterally amend the Master Covenant for any purpose with the prior written consent of the City of Austin. The Development and Sale Period is presently in effect. The City of Austin hereby consents to this Amendment by its execution of this instrument in the space provided below.
 - C. Master Declarant desires to amend the Master Covenant as set forth hereinbelow.

NOW THEREFORE, Master Declarant hereby amends and modifies the Master Covenant as follows:

- 1. Exhibit B. Exhibit "B" to the Master Covenant contains a map which depicting portions of the Community intended to be designated as EC/TC Tracts and as Mixed-Use Tracts. Exhibit "B" attached to the Master Covenant is hereby deleted in its entirety and the map attached hereto as Attachment "1" is substituted in its place. The Master Covenant anticipates that portions of the Property will be made a part of the Community by the recordation of an MCC Annexation Notice. The map is intended to be a reference, and the boundaries of the EC/TC Tracts and the Mixed-Use Tracts may be modified through an MCC Annexation Notice.
- 2. <u>Miscellaneous</u>. Any capitalized terms used and not otherwise defined in this Amendment shall have the meanings set forth in the Master Covenant. Unless expressly

amended by this Amendment, all other terms and provisions of the Master Covenant remain in full force and effect as written, and are hereby ratified and confirmed.


